WORLD OF WEB3 SUMMIT HONG KONG TICKETS – TERMS & CONDITIONS

Welcome to Hong Kong World of Web3 Summit 2024 (the "Event")! We hope you enjoy the Event.

These terms and conditions (these "**Terms**") apply between the person, firm, company or other entity specified on your registration form ("**you**" or "**your**") and Uvecon Limited, a limited liability company incorporated in Hong Kong with company number 2778386 which registered address is 1/F, 342 Ma Wan Main Street Village North, Ma Wan, New Territories, Hong Kong ("**we**", "**our**" or "**us**") to the purchase of your ticket (the "**Ticket**") to, and your attendance at, the Event. Please read them carefully as they contain important information.

By purchasing your Ticket to and/or attending the Event, you agree to be bound by these Terms to the exclusion of all other terms. If you do not agree to be bound by these Terms, please do not purchase the Ticket.

If you are accepting these Terms on behalf of an entity, you represent and warrant to us that you have the authority to do so (and for clarity, all other references to "you" in these Terms refer to such entity).

1. The Event

- 1.1. The Event will be held physically at AsiaWorld Expo at 1 Airport Expo Boulevard, Chek Lap Kok, Lantau Island, Hong Kong (the "**Venue**") between 26 March 2024 to 27 March 2024 and contains the following programs: (i) the conference hall, (ii) the business expo, (iii) the startup pitching, (iv) the NFT expo and (v) networking events. Further details regarding the Event, including the proposed agenda, program and location(s) of the Event on each day, are set out at <u>https://hongkong2024.wowsummit.net/</u>.
- 1.2. These Terms together with the full descriptions and details as mentioned in Condition 1.1 shall constitute the entire contract between you and us for the purchase of the Ticket(s) and your attendance at the Event, and shall supersede any previous terms and conditions, agreement or arrangement between us. You have not entered into the contract in reliance on, and shall have no remedy in respect of, any statement, representation, covenant, warranty, undertaking or indemnity (whether negligently or innocently) made by us other than as expressly set out in the contract.

2. Changes to these Terms

2.1. We reserve the right to modify, vary and change these Terms at any time at our discretion. Such modifications, variations and/or changes to the Terms shall be effective upon the posting of an updated version on this webpage. You agree that it shall be your responsibility to review these Terms regularly and your attendance at the Event after changes have been made to the Terms constitute your acceptance of the revised Terms.

3. Changes, Cancellation or Re-Schedule of the Event

- 3.1. We reserve the right to change, modify, or alter any aspect of the Event, without any compensation to you. We may, at any time and for any reason (acting reasonably) make alterations to the program, agenda, speakers, exhibitors, venue, dates, and timings of the Event. This website will be promptly updated to reflect any changes, modifications or alterations. Other than the aforesaid, no notice will be provided unless such changes, modifications or alterations are determined in our reasonable opinion to be material, in which event we will provide you with reasonable notice prior to such changes, modifications or alterations taking effect.
- 3.2. You understand that the activities and/or speakers for the Event may be changed and that such occurrence shall not, under any circumstances, entitle you to any claim whatsoever, including, but not limited to, a refund for your Ticket. You understand, acknowledge and agree that the descriptions of any activities or speakers contained in any Event promotional material is intended for informational purposes only and does not, in any way, represent the importance or headline status of any single activity or speaker, and is subject to change without prior notice.
- 3.3. If at any time we decide to cancel or reschedule the Event due to any reason, we will use our reasonable endeavours to notify you using the details you provided us with at the time of ordering. We do not guarantee that you will be informed of such cancellation or rescheduling before the date of the Event.
- 3.4. It is your responsibility to inform us of any change to your contact address, telephone number or email address you provided us with at the time of ordering.

4. Purchase of Your Ticket

- 4.1. To attend the Event, you must hold a valid Ticket. Unless otherwise specified, each Ticket admits one person only. Your Ticket will be delivered as an e-ticket to the email address provided when you ordered the Ticket. Unauthorised duplication of your Ticket may prevent your admittance to the Event. We are not responsible for any inconvenience caused by unauthorised duplication.
- 4.2. Subject to payment card verification and security checks, your Ticket is valid as soon as we have received full payment in cleared funds and will expire immediately after the performance of the Event. You must check your Ticket on receipt carefully and contact us immediately if there is a mistake.
- 4.3. All fees for the Tickets are payable in United States Dollars. All concessions and discounts are subject to availability, they may be restricted to certain price levels and performances and can be withdrawn by us without notice. Where a concession is claimed, proof of identity and concession entitlement (for example of age or other status) may be required.
- 4.4. The minimum age for entry is 18 years old. The Tickets may be restricted to a maximum number or sold subject to other restrictions on entry or use. Any such restriction shall be displayed on our website or otherwise notified to you before or at the time you purchase the Ticket. It is your responsibility to ensure that you read all notifications displayed on our website. We reserve the right to cancel Ticket(s) purchased in excess of the maximum number, without prior notice unless the purchase of Ticket(s) in excess was due to our error, in which case we will notify you prior to cancelling your Ticket.

- 4.5. The passes representing the Tickets have to be worn at all times during the Event. All participants are advised to bring along personal identification, as security checks may be carried out at our discretion.
- 4.6. We may prohibit any person from attending the Event for any reason (acting reasonably) and we shall not be liable to provide you with any refund or compensation.

5. Refund of Tickets

- 5.1. All Ticket(s) cannot be exchanged, cancelled or refunded after purchase unless the Event is cancelled or rescheduled.
- 5.2. Where the Event is cancelled or curtailed because of adverse weather, we shall not be liable to make any refund or pay any compensation beyond the refund that may be payable under the rules of the Venue.
- 5.3. Where an Event is cancelled or rescheduled for any reason other than adverse weather, you will be entitled to claim a refund from us in accordance with this Condition. You must bring this to our attention as soon as possible. The refund for a Ticket equals the price received by us for such Ticket.
- 5.4. Refunds shall only be made to the original person in our records who purchased the Ticket and, when possible, be made using the same method in our records as was used to purchase the Ticket.

6. Resale or Transfer of Tickets

- 6.1. All Tickets are non-transferrable.
- 6.2. You are not allowed to purchase any Tickets as agent for any third party or sell or otherwise transfer your Ticket to others, or exploit the Ticket commercially or non-commercially in any way.
- 6.3. Any resale or transfer (or attempted resale or transfer) of a Ticket in breach of the applicable law is a ground for seizure or cancellation of that Ticket without being liable to provide you and/or any involved party with any refund or compensation..

7. Void Ticket

7.1. Any Ticket obtained in breach of these Terms shall be void and all rights conferred or evidenced by such Ticket shall be void. Any person seeking to use such a void Ticket in order to gain or provide entry to the Event may be considered to be a trespasser and may be liable to be ejected and liable to legal action. Void Ticket(s) are non-refundable.

8. Visa requirements / invitation letter

- 8.1. It is your sole responsibility to ensure that you can attend the Event, including ensuring that you have the appropriate passport, visas for attending the Event. If you require a visa to attend the Event, please allow sufficient time for the visa application procedure.
- 8.2. To receive an invitation letter for the Event, you must first register and pay for your Ticket in full. After that, you can request by sending an email to info@wowsummit.net for an invitation letter.

9. Intellectual Property Rights

- 9.1. All rights to the Event belong to us, including any commercial rights and intellectual property rights arising from or in relation to the Event. Nothing in these Terms will act to license or transfer any rights of either party, except as expressly specified.
- 9.2. Possession of a Ticket does not confer any rights (by implication or otherwise) on you to use, alter, copy or otherwise deal with any of the symbols, trademarks, logos and/or intellectual property appearing on the Ticket.
- 9.3. Any Ticket cannot be used for advertising, promotions or contests, unless formal written permission is given by us, provided that even if such consent is obtained, use of our trademarks and other intellectual property is subject to our prior consent.
- 9.4. Taking photos or videos of a limited part of the Event is only allowed for your personal use (for the avoidance of doubt, any commercial purpose or use are prohibited).
- 9.5. By entering the Event, you are entering an area where photography, audio and video recording may occur. By attending the Event, you:
 - a) consent to be photographed, filmed, and/or otherwise recorded and to the release, publication, exhibition, or reproduction of any and all recorded media of your appearance, voice, and name for any purpose whatsoever in perpetuity in connection with the Event;
 - b) waive and release any claims you may have related to the use of recorded media of you at the Event, including, without limitation, any right to inspect or approve the photo, video or audio recording of you, any claims for invasion of privacy, violation of the right of publicity, defamation, and copyright infringement or for any fees for use of such record media
 - c) grant us a perpetual, royalty free, worldwide licence to use your actual or simulated likeness in connection with the production, exhibition, advertising or exploitation of any film, video and/or audio recording of the Event (or any part of it), in any media (e.g. in future marketing materials). If you have any concerns about this, please notify us prior to attending the Event; and
 - d) consent to being filmed by police or security staff for the purpose of ensuring public security at the Event and preventing crime.
- 9.6. You understand that all photography, filming and/or recording will be done in reliance on this clause. If you do not agree to the foregoing, please do not enter the Event premises.

10. Conditions of Admission and Attendance

10.1. The Venue manager reserves the right to refuse your admission to the Venue in reasonable circumstances including for health and safety, licensing reasons or where a Ticket is void.

- 10.2. You may be asked to scan your Ticket with us at the Venue or at exhibition booths or session rooms throughout the Event.
- 10.3. The Venue manager reserves the right to conduct security searches from time to time and confiscate any item which, in the reasonable opinion of the Venue manager, may cause danger or disruption to other members of the audience or the Event or is one of the items not permitted in the Venue as listed below. The following are not permitted within the Venue:
 - a) animals (with the exception of assistance dogs);
 - b) laser pens, fireworks, flares, smoke bombs;
 - c) your own food and drink (unless permitted by the Venue);
 - d) any item which may be interpreted as a potential weapon including sharp or pointed objects (e.g. knives); and
 - e) illegal substances.
- 10.4. The Venue manager also reserves the right to request that you leave the Venue at any point on reasonable grounds and may take any appropriate action to enforce this right. By way of example, the Venue manager may remove a Ticket holder who:
 - a) has behaved in the Venue in a manner which, in the reasonable opinion of the Venue has, or is likely to affect the enjoyment of other visitors; or
 - b) uses threatening, abusive or insulting words or behaviour or in any way provokes or behaves in a manner which may provoke a breach of the peace; or
 - c) in the reasonable opinion of the Venue is under the influence of drugs or has consumed an excessive amount of alcohol; or
 - d) fails, when required, to produce proof of identity or age.
- 10.5. No refunds will be given to Ticket holders who are refused entry or ejected due to their own behaviour as suggested in, but not limited to, the examples above.
- 10.6. You must comply with all relevant statutes, safety announcements and Venue regulations whilst attending the Event. If you have any special requirements or concerns about any special effects which may be featured at the Event, prior notice should be provided when ordering Tickets. Special effects may include, without limitation, sound, audio visual, pyrotechnic effects or lighting effects.

11. Data privacy

- 11.1. By registering for the Event, you agree that your personal information as stated in the registration form and provided by you during the Event may be collected, used and disclosed by us (including our partners and authorised agents) for the purpose of the Event, including the facilitating and processing of payment and for marketing and business matching.
- 11.2. We will make our best endeavours to ensure that your personal information is protected against misuse and loss, or unauthorized access, modification or disclosure and will promptly notify you of any loss of, or any unauthorized disclosure of or access to, your personal information. We will always respect your privacy, and treat your personal data in accordance with:
 - a) Our privacy policy at https://wowsummit.net/privacy-policy/; and
 - b) Hong Kong data privacy laws.

11.3. You can elect whether to share your personal information at the Event to exhibitors and sponsors. When your personal information is shared at the Event to an exhibitor and/or a sponsor, you agree to receive communications from that entity. Your personal data will be treated in accordance with that entity's privacy policy, and you may unsubscribe from such communications by contacting them directly.

12. Liability

- 12.1. To the fullest extent permitted by the applicable law, neither we nor the Venue nor the partner(s) nor the sponsors will be responsible for:
 - a) any liability for loss, injury or damage to persons or property at the Event;
 - b) any indemnities, warranties, representations, terms and conditions (whether express or implied); and
 - c) any actual or alleged indirect loss or consequential loss howsoever arising suffered by you or any loss of profits, anticipated profits, savings, loss of business revenue, loss of business, loss of opportunity, loss of goodwill, or any other type of economic loss (whether direct or indirect).
- 12.2. If we are liable to you for any reason, our total liability to you in relation to the Event (whether under these terms or conditions or otherwise) is limited to the amount of Ticket price received by us. To the fullest extent permitted by the applicable law, we shall not be liable to you for any loss, delay, damage or other liability incurred resulting from or arising in connection with the cancellation or date change of the Event howsoever arising or any venue change. Personal arrangements including travel, accommodation or hospitality relating to the Event which have been arranged by you are at your own risk.
- 12.3. You are responsible for your own valuables, and we will not be liable for any loss or damage to personal property brought to the Event.
- 12.4. Views expressed by all speakers at the Event are their own. We are not liable for any advice given or views expressed by any speakers or in any materials provided to attendees.

13. Prohibited material and behaviour

- 13.1. We prohibit the following from the Event:
 - a) illegal drugs, substances or materials;
 - b) any political materials;
 - c) any unauthorised materials for trading (including any goods or items using unauthorised event logos or brands); and
 - d) any other item which (in our opinion) interferes with the safe or effective operation of the Event.
- 13.2. We prohibit the following behaviour at the Event:
 - a) unauthorised photography or use of recording equipment and zoom lenses, audio visual or cinematographic devices;
 - b) unauthorised merchandising;
 - c) harassment which includes verbal comments that reinforce social structures of domination related to gender, gender identity and expression, sexual orientation, disability, physical appearance, body size, race, age, religion, sexual images in public spaces, deliberate intimidation, stalking, following, harassing photography

or recording, sustained disruption of talks or other events, inappropriate physical contact, and unwelcome sexual attention; or

- d) any other act which (in our opinion) interferes with the safe or effective operation of the Event.
- 13.3. We may (at our sole discretion) refuse admission to, or eject from the Event, any person in our absolute discretion without liability to such person, including (without limitation) any person who fails to comply with these terms and conditions or who in our reasonable opinion represents a security risk, nuisance or annoyance to the running of the Event. You agree to comply with all reasonable instructions issued by us or the Venue owners at the Event.

14. Force majeure

- 14.1. We are not liable for any delay or failure to perform these Terms (including hosting the Event) to the extent such delay or failure is caused by any Force Majeure Event. For the purposes of these Terms, "Force Majeure Event" means any circumstance outside of our reasonable control, and includes by way of example only the following:
 - a) acts of God, flood, drought, earthquake or other natural disaster;
 - b) epidemic or pandemic;
 - c) terrorist attack, civil war, civil commotion or riots, war, threat of or preparation for war, armed conflict, imposition of sanctions, embargo, or breaking off of diplomatic relations;
 - d) any law or any action taken by a government or public authority;
 - e) collapse of buildings, fire, explosion or accident;
 - f) any labour or trade dispute, strikes, industrial action or lockouts;
 - g) non-performance by suppliers or subcontractors;
 - h) interruption or failure of any utility or public transportation service in Hong Kong;
 - i) non-performance by suppliers or subcontractors;
 - j) any event outside of our control that has an adverse effect on the Event, including:
 - i. any public demonstration or protests; or
 - ii. any governmental action that has a material adverse effect on the Event; and
 - k) any other circumstance outside of our control that leads us to believe (acting reasonably) that the Event cannot be safely or effectively hosted, or where significant changes would need to be made to the Event in order for it to be hosted.

15. General

- 15.1. Should you have any queries or complaints relating to your Ticket purchase, please contact our ticketing team by email info@wowsummit.net. We will use our best endeavours to acknowledge all customer correspondence within 24 hours.
- 15.2. The standard version of these Terms shall be in the English language. In the event of any inconsistency between the translations of these Terms (if any) and the standard version thereof, the standard version shall prevail.
- 15.3. If it is found by a competent court that any of these Terms for any reason cannot be enforced, this shall not prevent the other provisions from continuing to apply.

- 15.4. Unless stated otherwise in this Agreement, neither Party will be treated as having waived any rights by not exercising (or delaying the exercise of) any rights under this Agreement.
- 15.5. We may assign any of our rights and obligations under these Terms to any third party. We may delegate or sub-contract any or all of its obligations under these Terms to any of our service providers, provided that we remain responsible to you for the performance of our obligations under these Terms.
- 15.6. These Terms are governed by and construed in all respects in accordance with the laws of Hong Kong, and any disputes arising out of these Terms are subject to the exclusive jurisdiction of the courts of Hong Kong.
